

**NOTICE OF 2022 PRIMARY ELECTION**

Notice is hereby given that on Tuesday, the 10<sup>th</sup> day of May, 2022, a Primary Election will be held in Kimball County, Nebraska, at the following polling places: **FIRST WARD, SECOND WARD, & ANTELOPE**—Kimball Event Center, 615 East 3<sup>rd</sup> Street, Kimball; **BUSHNELL**—Bushnell Fire Hall, Bushnell; **DIX**—Dix Fire Hall, Dix.

The polls shall open at 7:00 a.m. and remain open until 7:00 p.m. the same day.

In compliance with Section 32-811 Election Laws of Nebraska, in those cases where the names of candidates filed do not exceed two candidates for each vacancy to be filled, all so filed shall be declared nominated and their names shall not appear on any primary election ballot. Therefore, the candidates of the County Offices of Commissioner, Assessor, Attorney, Clerk, Clerk of District Court, Surveyor and Treasurer, Western Community College District 2, South Platte NRD Sub-District 2, Kimball School District 1, Potter-Dix School District 9, City of Kimball Mayor, City of Kimball Council and City of Kimball Airport Authority shall receive a certificate of nomination and the candidates shall have their names placed on the November 8, 2022, General Election Ballot.

Any amendments or referendums to be voted upon will be published by the Secretary of State once each week for three consecutive weeks preceding the election.
